

## IRT Trading Conditions

1. The Consignor warrants that he is either the owner of the livestock consigned or is authorised agent and accepts these conditioned for himself and those for whom he is acting. The Company shall not be bound to recognise any title to the livestock in any person other than the consignor. Should the Company however receive evidence which in its uncontrolled discretion the Company may deem sufficient to establish title in any person other than the Consignor the Company may if it desires act upon such evidence, but shall not incur any liability to the Consignor or to any other person by reason of so acting.
2. The Consignor warrants that the livestock is in all respects fit and suitable for consignment of the intended journey.
3. Where import regulations of the country of destination require certification(s) relating to the health of livestock, the cost of any necessary veterinary examination and/or test shall be borne by the Consignor and is not included unless otherwise stated in any quotation.
4. If the cost of freight or any insurance required to be effected by the Company is increased above the rates ruling at the date of quotation the excess shall be payable by the Consignor.
5. The Company shall be under no obligation to forward the livestock until the freight and all other charges payable by the Consignor have been paid.
6. If the company shall require to board or produce the boarding of the livestock before consignment to a carrier can be arranged or at any stage in the journey or where owing to circumstances beyond the control of the Company there is a delay in forwarding the livestock or until payment of any sum due in respect of such livestock is received, the cost of such board and expenses incidental thereto including any necessary medicine or veterinary treatment, re-examination required by the import regulations of the country of destination, shall be payable by the Consignor without prejudice to the Company's rights against any other person.
7. Livestock delivered to the Company shall be held by it subject to a lien not only for the Company's charges in respect of the particular livestock, but also for any general balance of account due from the Consignor. In the event of any charges or other monies due from the Consignor to the Company not being paid, the Company may within its absolute discretion at any time while the livestock is in its possession, custody or control, after giving such notice as may be practicable, destroy, give away, sell or otherwise dispose of the livestock and, out of the proceeds arising from the sale or other disposition thereof, retain all sums due and owing to the Company from the Consignor at the time of the receipt by the Company of such proceeds or thereafter accruing, together with the costs, charges, and expenses incurred by the Company in the disposition of the livestock and this condition shall be without prejudice to the right of the Company to recover from the Consignor any monies, including such costs, charges, and expenses that may be due to the Company
8. Livestock is forwarded by the Company subject to the Conditions of the steamship company or other carrier governing such freight.
9. All duties, taxes, imports or levies of any kind payable at the port of destination, and except when a thorough quotation is given by the Company, any expenses properly incurred in relation to the livestock after arrival at the port of destination before delivery to the Consignee are payable by the Consignee but the Consignor shall indemnify the Company against any such payments which the Company shall be required or deem it necessary to make.
10. Livestock is accepted by the Company solely at the risk of the Consignor and the Company its servants and agents shall be under no liability in contract, tort or otherwise for the death, illness, or escape thereof or injury thereto from whatsoever cause arising, nor for any loss or damage suffered by the Consignor or anyone claiming through him by reason of anything done or omitted by the Company its servants or agents in connection with such livestock.
